What is Household Hazardous Waste (HHW)?

HHW is products in your home that have one of the following characteristics: corrosivity, toxicity, flammability or reactivity. These household items aren't considered waste until you need to dispose of them. For example, old oil-based paint, expired medicines and mercury thermometers are all HHW.

If you are not sure if an item in your home is hazardous, read the label. Warnings such as "poison or toxic", "flammable or ignitable", "corrosive" are clear signs. Cleaners that contain strong acids, bleach or ammonia are also hazardous.

To determine if your paint products are hazardous, read the label. When in doubt, read the clean-up instructions. If it says to clean up with soap and water, the paint is latex and therefore, non-hazardous. If it says to clean up with mineral spirits or paint thinner, the paint is hazardous.

Listed below are examples of household hazardous waste.

The following items WILL BE ACCEPTED at the HHW events:

Kitchen/Bathroom

- Bleach, ammonia
- Drain cleaners
- Mercury thermometers
- Aerosol cans
- Expired medicines
- Nail polish
- Metal polish with solvent

Workshop

- Fluorescent bulbs
- Glue—solvent based
- Oil-based paint and primer
- Solvents, paint thinner
- Turpentine
- Varnish
- Wood preservatives

Garden

- Pesticides, herbicides, fungicides, insecticides
- Weed and Feeds
- Deck wash

Miscellaneous

- Batteries (all kinds)
- Mercury
- Moth balls
- Small propane tanks
- Acids
- Aerosols
- Pool chemicals
- Fiberglass epoxy
- Lighter fluid
- Photo chemicals

Garage

- Used oil
- Brake, transmission fluids
- Gasoline, kerosene, diesel fuel, fuel oil
- Car batteries and battery acid
- Antifreeze

Home Office

- Used computer equipment including: CPUs, monitors, mice, keyboards, scanners, printers and modems

The following items are not accepted: latex paint, unknowns, commercial waste, fire extinguishers, flares, ammunition, and smoke detectors.

Paper shredding is available at all HHW events. There is a 100-pound or 3-box limit per household.
